## Local Initiatives



### Stabilize Placements For Children Until They Have a Forever Home

We stabilize placements for children until they have a forever home. Not all children in foster care can go home right away.

### Prevent Children From Entering the System

We prevent children from entering the system whenever possible. Prevention is equally crucial in foster care, and separation should always be a last resort.

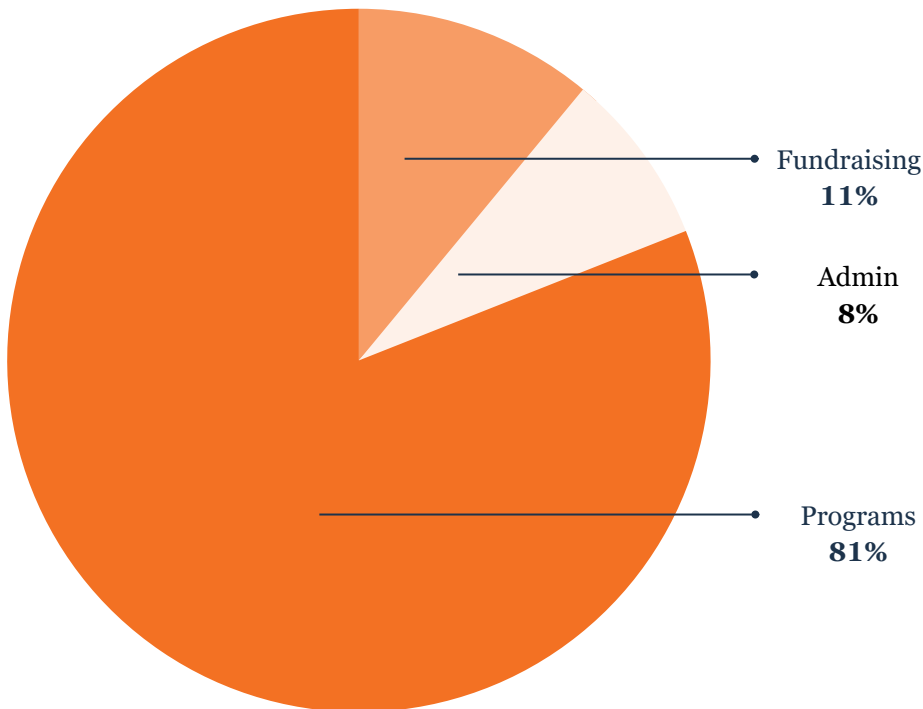
